CIRCULAR

Subject: Implementation of Aadhaar Biometric Authentication drive for beneficiaries & L-1 (Head of Institutes/Institute Nodal Officer) in collaboration with NSP, NIC and Common Service Centers (CSC) under Center Sector Schemes for minority (i.e. Pre-& Post-Matric and Begum Hazrat Mahal National Scholarship schemes for minority category students of Ministry of Minority Affairs (MoMA), Govt. of India at National Scholarship Portal for the academic session 2022-23

Kind attention is invited to the letter bearing No. F.43(23)/CSSScholarship/2022-23/184-197 dated 04.08.2023 received from State Nodal Officer (Scholarship), Revenue Department, GNCT of Delhi regarding the subject cited above vide which is intimated that MoMA, Gol has decided to carry out bio-authentication of all beneficiaries, Level-1 & Level-2 officials in collaboration with NSP, NIC and Common Service Centre (CSC) to weed out fraudulent elements from 26 lakh scholarship applications under all scholarship schemes for minority on National Scholarship Portal for the year 2022-23. In compliance of the instructions given by MoMA, Gol, Revenue Department, GNCT of Delhi is organizing Aadhaar Biometric Authentication drive with collaboration of CSCs so that disbursement of Scholarship of A. S. 2022-23 can be made to genuine and eligible beneficiaries.

In this regard, the timelines for completion of the entire Biometric Authentication and re-verification of applications drive under Central Sector Scholarship schemes for minority for the year 2022-23 of MoMA, Gol are as follows:

Description of activity	Timeline
Uploading Aadhaar on portal	01.08.2023 to 10.08.2023
Verification of DNO/SNO	01.08.2023 to 05.08.2023
Verification of Hol/INO	01.08.2023 to 10.08.2023
Verification of students	05.08.2023 to 20.08.2023
Verification of applications by Hol/INO	05.08.2023 to 23.08.2023
Verification of applications by DNO	10.08.2023 to 25.08.2023

In view of the above, concerned Head of all types of Schools are requested to facilitate VLEs of CSCs with proper seating arrangement with internet facilities so that Biometric Authentication drive for all Hols/INOs/Beneficiaries of Central Sector Scholarship Schemes for Minority of MoMA, Gol may be completed within the aforementioned stipulated timelines.
