6. The Organization/Researcher has to ensure that no damages occur while conducting the program. It will be the sole responsibility of the Organization and it should be rectified to the entire satisfaction of the HoS, if there is any damage.
7. The permission is purely provisional and liable to be withdrawn at any time, if it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms and conditions.
8. The DoE will indemnify against any legal/financial liability/litigation that may arise out of the project process or its findings.
9. Ensure that the Covid-19 protocol is being followed strictly.
